CONDITIONS OF USE

- A Season Pass is not transferable.
- 2. A Season Pass is the property of the Council, but until its expiration may be held and shall be used only by the subscribers to whom it is issued, and if lent or transferred to or, in the opinion of the Council, used or attempted to be used by any other person, shall immediately expire and cease to be recognised as valid by the Council (to which it shall be forthwith returned or by which it may at anytime be impounded) and no refund shall be payable in respect of any unexpired portion thereof. A further Pass will not be issued unless the expired Pass is returned.
- 3. Before a Season Pass holder may enter the Swimming Centre they shall first have passed their Season "Swipe" Card through the turnstile (and had said card accepted as valid) and shall, if required by the Centre Co-ordinator or any other employee of the Swimming Centre, produce their pass to the Centre Co-ordinator or such other employee for verification and furnish all reasonable information regarding the same. Any pass holder failing to produce their Pass when seeking admission to the Swimming Centre may be required to pay the prescribed admission fee.
- 4. Should a Season Pass holder lose their pass, they shall give immediate notice of such loss to the Council or the Swimming Centre Co-ordinator and on being furnished with proof of identity to the satisfaction of the Council, the Council may (but without any obligation to do so) issue a duplicate Pass to the subscriber on payment of ten dollars (\$10.00).
- 5. Partial/pro rata refunds will not be issued for unused season passes. Season passes cannot be transferred. Unused season passes will not be refunded exchanged or credited and cannot be transferred to another individual(s) or family/families.
- 6. The Council takes no responsibility for damages to the card while in the care of the cardholder. A replacement fee of \$10.00 will be charged for all cards damaged requiring replacement, whilst in the care of the cardholder. Council takes no responsibility for the misuse of cards whilst in the care of the nominated cardholder. Please see reverse of card for care instructions.
- 7. Manly Swim Centre respects your privacy. Our purpose in collecting personal information from you is to help us provide you with better service. We will not wilfully or deliberately disclose any individually identifiable information about you to any third party without first receiving your permission.
